

#### **□** LAW ON NATURE PROTECTION

THE CONDITIONS AND METHODS FOR THE PROTECTION AND PRESERVATION OF NATURE ARE BEING REGULATED, AND E-MOBILITY IS NOT SUBJECT TO THE LAW.







#### ☐ LEGAL ACTS IN THE FIELD OF TRAFFIC

THE ISSUE OF CHARGING/REFUELING STATIONS FOR ELECTRIC VEHICLES IS NOT SPECIFICALLY REGULATED, EXCEPT FOR THE PART RELATED TO THE INSTALLATION OF ELECTRIC WIRES. THE LAWS IN THIS AREA ALSO DO NOT TRANSPOSE DIRECTIVE 2014/94/EU ON THE DEPLOYMENT OF **ALTERNATIVE FUELS** INFRASTRUCTURE, NOR DO THEY PROVIDE FOR THE ADOPTION OF A NATIONAL POLICY FRAMEWORK.

□ LAW ON SPATIAL PLANNING CONSTRUCTION OF BUILDINGS

**AND** 

TREATMENT WAS NOT GIVEN TO CHARGING STATIONS FOR **ELECTRIC VEHICLES IN TERMS OF** RECOGNIZING THE CHARGING/SUPPLYING STATIONS FOR ELECTRIC MOTOR VEHICLES, THEIR OBLIGATION TO BE INCLUDED IN SPATIAL PLANNING ACTS OR POTENTIAL FACILITATION OF CONDITIONS FOR THEIR CONSTRUCTION.
